ITEM 4: Approval of Earned Income Verification Guidance Document

Mr. DiStefano spoke to the Board about the Cover letter and Guidance document that accompanies the Earned Income Disclosure Statement for disability retirees. The Board had previously approved these documents. However, new legislation has changed the statute and now only disability members that are required to fill out the Earned Income Disclosure form are members that have not reached normal retirement age. Mr. DiStefano and the retirement office have worked on updating the documents to reflect the change in statute.

On motion by Mr. Wisner, seconded by Mr. Isabelle, the Board unanimously voted by roll call to approve the cover letter and guidance document for the Disability Earned Income Disclosure Statement.

ITEM 5: Renewal of Michael Zimmerman/Disability Hearing Contract

This is an infrequently used service, typically only once or twice a year. The rate remains unchanged at \$75 per hour, capped at \$9,000, plus \$1,000 of expenses.

On motion by Mr. Wisner, seconded by Mr. Ferland, the Board voted unanimously by roll call to extend the contract waiver for Michael Zimmerman, for one year to 12/31/2017 to serve as the disability hearing officer.
