ITEM 1: Approve the Minutes of:

ITEM 2: Review/Act on the OPEB Report

Ms. Pearce explained that the FY17 OPEB Report is not yet available for action by the Board and suggested the Board postpone action on this item until the December 14, 2017 meeting.

ITEM 3: Disability Retirement recommendation for:

On a motion by Mr. Norris, seconded by Mr. Mackey, the Board voted unanimously to approve the recommendation of the MRB to grant disability retirement for Sarah Kirn without further review.

ITEM 4: Review Title 16 Proposed Language

Mr. Duggan presented proposed changes to Title 16 as discussed and drafted with input from the Retirement Office Director and staff. Proposed changes include eliminating archaic language that no longer applies to any active members or beneficiaries, bringing the disability review language in line with the State system, and clarifying language around the pension fund and health benefit fund.

The Board discussed the changes to the disability retirement language, and requested to see revised language around reemployment and Board discretion on removing a benefit at the end of the 2-year period. Mr. Duggan with Retirement staff will revise the language to address the Board's concerns. Ms. Pearce suggested the revised language be brought before the Board at the next meeting for further discussion and a potential vote.

ITEM 5: Review/adopt Proposed 2018 Meeting Schedule

Retirement staff put forward a proposed 2018 Meeting Schedule, keeping the quarterly in-house meetings on the second Tuesday of the month and all other conference call meetings on the second Thursday of the month.

On a motion made by Ms. Pearce, seconded by Mr. Norris, the Board voted unanimously to adopt the 2018 meeting schedule as proposed.

ITEM 6: Other Business

On a motion made by Ms. Pearce, seconded by Mr. Norris, the Board voted unanimously to move into Executive Session at 3:58 p.m. pursuant to 1 V.S.A. § 313 for the purpose of discussing contract negotiations.

The Board came out of Executive Session at 4:15 p.m.

Mr. Duggan informed the Board that a request for quotation for a hearing officer for disability retirement appeals was advertised with the Vermont Bar Association. Quotations are due back to the Retirement Office by December 1, 2017.
